The applicant must submit a certification that materials used meet the Township’s Construction and Materials Specifications. A certified compaction test result from the soil testing laboratory shall be submitted once the work is complete. It is the contractor/applicant’s responsibility to email requests for inspections on each day of work. A \$200 inspection fee will be deducted from the deposit for each inspection. Failure to comply will result in an action being brought before the district justice under a summary offence, which is subject to a fine of \$1,000, plus costs, per day the violation exists. Failure to pay said fines could result in imprisonment not to exceed 90 days per day violation exists.

The applicant certifies that all information on this application is correct, and the work will be completed in accordance with the "approved" construction documents, The Construction and Materials Manual and any additional approved building code requirements adopted by the Municipality. **The road will be restored to the PennDOT standards as defined in 67 Pa. Code §459.8.** The applicant assumes the responsibility of locating all property lines, setback lines, easements, rights-of-way, flood areas, etc. Issuance of a permit and approval of construction documents shall not be construed as authority to violate, cancel, or set aside any provisions of the codes or ordinances of the Municipality or any other governing body. The applicant certifies he/she understands all the applicable codes, ordinances, and regulations.
